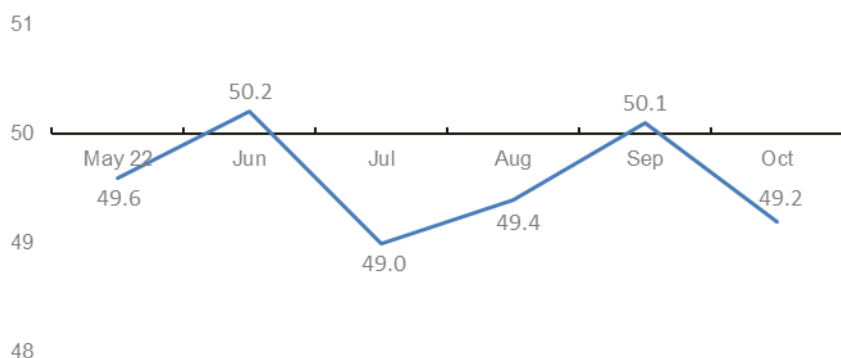


# PMI Report on China Manufacturing

## China’s manufacturing PMI falls to 49.2 in October, indicating downward pressure on the manufacturing sector

8 of the 13 sub-indices were lower than their respective levels in the previous month. For example, the new orders index fell by 1.7 pts to 48.1 in October, indicating that the overall demand has contracted at a faster pace recently. Against this backdrop, the output index dropped by 1.9 pts to 49.6 in the month, returning to the contractionary territory after a one-month expansion. Besides, the purchases of inputs index went down to 49.3 in October, indicating a reduction in purchasing activities. Also noteworthy is that while the input prices index continued to rise to 53.3 in October, the ex-factory prices index remained below 50, registering 48.7 in the month.

By size of enterprises, the PMI of 'large enterprises' declined to 50.1 in October from 51.1 in September. The PMI of 'medium enterprises' fell to 48.9 in October from 49.7 in September. The PMI of 'small enterprises' edged down to 48.2 in October from 48.3 in September.

The output index dropped to 49.6 in October from 51.5 in September. The output index of 'large enterprises' remained above the neutral level of 50, registering 51.3 in October. Meanwhile, the output indices of 'medium enterprises' and 'small enterprises' were both below 50, registering 48.8 and 47.8 respectively in the month.

The new orders index went down to 48.1 in October from 49.8 in September. By size of enterprises, the new orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all in the contractionary zone, registering 49.6, 47.4 and 46.7 respectively in October.

The new export orders index went up from 47.6 in October from 47.0 in September. The new export orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 49.3, 44.9 and 45.3 respectively in October.

The backlogs of orders index fell to 43.9 in October from 44.1 in September. The backlogs of orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 45.1, 43.0 and 42.4 respectively in October.

The stocks of finished goods index rose to 48.0 in October from 47.3 in September. The stocks of finished goods indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 48.6, 47.3 and 47.6 respectively in October.

The stocks of major inputs index edged up to 47.7 in October from 47.6 in September. The stocks of major inputs indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 48.2, 48.0 and 46.2 respectively in October.

The purchases of inputs index went down to 49.3 in October from 50.2 in September. The purchases of inputs index of 'large enterprises' remained above the neutral level of 50, registering 51.1 in October. Meanwhile, the purchases of inputs indices of 'medium enterprises' and 'small enterprises' both stayed in the contractionary zone, registering 48.0 and 47.2 respectively in the month.

The imports index decreased to 47.9 in October from 48.1 in September. The imports indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 47.6, 48.3 and 49.2 in October.

The input prices index rose to 53.3 in October from 51.3 in September. The input prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained above the neutral level of 50, registering 52.9, 52.0 and 56.0 in October.

The ex-factory prices index came in at 48.7 in October, up from 47.1 in September.<sup>1</sup> The ex-factory prices index of 'small enterprises' remained above the neutral level of 50, registering 51.4 in October. Meanwhile, the ex-factory prices indices of 'large enterprises' and 'medium enterprises' both remained below the critical 50-mark, registering 47.1 and 49.5 respectively in the month.

The employment index went down to 48.3 in October from 49.0 in September. The employment indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 48.5, 47.8 and 48.6 respectively in October.

The suppliers' delivery time index came in at 47.1 in October, down from 48.7 in September. A reading above 50 implies faster delivery; below 50, slower delivery. The suppliers' delivery time indices of 'large enterprises', 'medium enterprises' and 'small enterprises' registered 47.8, 46.1 and 47.1 respectively in October.

The business expectations index went down to 52.6 in October from 53.4 in September.<sup>2</sup> The business expectations indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 53.7, 52.1 and 50.9 respectively in October.

## CFLP

### 中國物流與採購聯合會

China Federation of Logistics & Purchasing (CFLP) is the logistics and purchasing industry association approved by the State Council. CFLP's mission is to push forward the development of the logistics industry and the procurement businesses of both government and enterprises, as well as the circulation of factors of production in China. The government authorizes the CFLP to produce industry statistics and set industry standards. CFLP is also China's representative in the Asian-Pacific Logistics Federation (APLF) and the International Federation of Purchasing and Supply Management (IFPSM).

## NBS

### 國家統計局

The National Bureau of Statistics (NBS), an agency directly under the State Council in China, is in charge of the country's statistics. It is responsible for formulating statistical policies and establishing the national statistical system, drafting and enforcing the statistical laws and regulations, setting up and improving the national economic accounting system, conducting censuses, as well as making statistical analyses and forecasts of the macroeconomy, social development, scientific advancement, resources and environment.

## China Manufacturing PMI

### 中國製造業採購經理指數

China Manufacturing Purchasing Managers' Index (PMI) provides an early indication each month of economic activities in the Chinese manufacturing sector. It is jointly published by China Federation of Logistics & Purchasing (CFLP) and the National Bureau of Statistics (NBS). Fung Business Intelligence is responsible for drafting and disseminating the English PMI report.

Every month questionnaires are sent to 3,000 manufacturing enterprises all over China. The data presented herein is compiled from the enterprises' responses about their purchasing activities and supply situations. CFLP makes no representation regarding the data collection procedures, nor does it disclose any data of individual enterprises. The PMI should be compared to other economic data sources when used in decision-making.

3,000 manufacturing enterprises in 31 industries from Eastern, Northeastern, Central and Western China are surveyed. The sampling of the enterprises involves the use of Probability Proportional to Size Sampling (PPS), which means the selection of enterprises surveyed is largely based on each industry's contribution to GDP, and the representation of each geographical region.

There are 13 sub-indicators in the survey: Output, New Orders, New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Purchases of Inputs, Imports, Input Prices, Stocks of Major Inputs, Ex-factory Prices, Employment, Suppliers' Delivery Time and Business Expectations. An index reading above 50 indicates an overall positive change in a sub-indicator; below 50, an overall negative change.

The PMI is a composite index based on the seasonally adjusted indices for five of the sub-indicators with varying weights: New Orders—30%; Output—25%; Employment—20%; Suppliers' Delivery Time—15%; and Stocks of Major Inputs—10%. A PMI reading above 50 indicates an overall expansion in the manufacturing sector; below 50, an overall contraction.

Currently there are more than twenty countries and regions conducting the PMI survey and compilation, based on an internationally standardized methodology.
