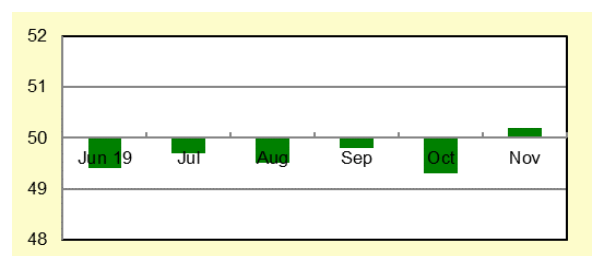

PMI rises to 50.2 in November

Output, New Orders, Purchases of Inputs, Expanding. New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Stocks of Major Inputs, Imports, Employment, Contracting. Input Prices, Ex-factory Prices, Falling. Suppliers' Delivery, Faster. Business Expectations, Optimistic.

China's manufacturing PMI went up from 49.3 in October to 50.2 in November, rising above the critical 50-mark for the first time since April. The latest figure indicates an expansion of the manufacturing sector in China.

8 of the 13 sub-indices were higher than their respective levels in the previous month. For example, the new orders index returned to the expansionary zone in November. Meanwhile, the new export orders index rose by 1.8 pts from the previous month to 48.8 in November, indicating that new export orders have dropped at a slower pace recently. Against this backdrop, the growth of production activities has quickened: the output index increased by 1.8 pts from the previous month to 52.6 in November. Besides, the purchases of inputs index went up to 51.0 in the month, indicating an increase in purchasing activities.

By size of enterprises, the PMI of 'large enterprises' came in at 50.9 in November, up from 49.9 in October. The PMI of 'medium enterprises' rose to 49.5 in November from 49.0 in October. The PMI of 'small enterprises' went up to 49.4 in November from 47.9 in October.

The output index came in at 52.6 in November, up from 50.8 in October. The output indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all above the critical 50-mark, registering 53.5, 52.0 and 51.0 respectively in November.

The new orders index rose to 51.3 in November from 49.6 in October. By size of enterprises, the new orders index of 'large enterprises' came in at 52.1 in November, up from 50.1 in October; and the new orders index of 'small enterprises' registered 50.6 in November, up from 46.8 in October. Meanwhile, the new orders index of 'medium enterprises' was 50.2 in November, down from 50.5 in October.

The new export orders index was 48.8 in November, up from 47.0 in October. The new export orders indices of 'large enterprises' and 'medium enterprises' remained below the neutral level of 50, registering 48.9 and 48.2 respectively in November. Meanwhile, the new export orders index of 'small enterprises' came in at 50.0.

The backlogs of orders index came in at 44.9 in November, the same as in October. The backlogs of orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all below the critical 50-mark, registering 45.7, 45.1 and 42.3 respectively in November.

The stocks of finished goods index was 46.4 in November, down from 46.7 in October. The stocks of finished goods indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed below the neutral level of 50, registering 47.9, 45.6 and 43.4 respectively in November.

The purchases of inputs index went up to 51.0 in November from 49.8 in October. The purchases of inputs index of 'large enterprises' came in at 52.6 in November. Meanwhile, the purchases of inputs indices of 'medium enterprises' and 'small enterprises' remained in the contractionary zone, registering 49.9 and 48.1 respectively in the month.

The imports index jumped to 49.8 in November from 46.9 in October. The imports index of 'large enterprises' was 50.4 in November. Meanwhile, the imports indices of 'medium enterprises' and 'small enterprises' stayed below the critical 50-mark, registering 48.0 and 49.8 respectively in November.

The input prices index went down to 49.0 in November from 50.4 in October. The input prices indices of 'medium enterprises' and 'small enterprises' remained above 50, registering 50.1 and 51.9 respectively in November. Meanwhile, the input prices index of 'large enterprises' fell to 47.4 in the month.

The ex-factory prices index was 47.3 in November, down from 48.0 in October.¹ The ex-factory prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were below the neutral level of 50, registering 46.5, 47.9 and 48.5 respectively in November.

The stocks of major inputs index went up to 47.8 in November from 47.4 in October. The stocks of major inputs indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 48.7, 47.1 and 46.3 respectively in November.

The employment index was 47.3 in November, the same as in October. The employment indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 48.1, 46.3 and 46.5 respectively in November.

The suppliers' delivery time index came in at 50.5 in November, compared with 50.1 in October. A reading above 50 implies faster delivery; below 50, slower delivery. The suppliers' delivery time indices of 'large enterprises', 'medium enterprises' and 'small enterprises' registered 50.9, 50.3 and 49.7 respectively in November.

The business expectations index went up to 54.9 in November from 54.2 in October.² The business expectations indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 54.7, 56.0 and 53.7 respectively in November.

¹ The ex-factory prices index has been published since January 2017.

² Since January 2017, a new method of seasonal adjustment to the business expectations index has been adopted; and accordingly, the historical readings of the index have been revised.

About China Manufacturing PMI:

China Manufacturing Purchasing Managers' Index (PMI) provides an early indication each month of economic activities in the Chinese manufacturing sector. It is jointly published by China Federation of Logistics & Purchasing (CFLP) and the National Bureau of Statistics (NBS). Fung Business Intelligence is responsible for drafting and disseminating the English PMI report.

Every month questionnaires are sent to 3,000 manufacturing enterprises all over China. The data presented herein is compiled from the enterprises' responses about their purchasing activities and supply situations. CFLP makes no representation regarding the data collection procedures, nor does it disclose any data of individual enterprises. The PMI should be compared to other economic data sources when used in decision-making.

3,000 manufacturing enterprises in 31 industries from Eastern, Northeastern, Central and Western China are surveyed. The sampling of the enterprises involves the use of Probability Proportional to Size Sampling (PPS), which means the selection of enterprises surveyed is largely based on each industry's contribution to GDP, and the representation of each geographical region.

There are 13 sub-indicators in the survey: Output, New Orders, New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Purchases of Inputs, Imports, Input Prices, Stocks of Major Inputs, Ex-factory Prices, Employment, Suppliers' Delivery Time and Business Expectations. An index reading above 50 indicates an overall positive change in a sub-indicator; below 50, an overall negative change.

The PMI is a composite index based on the seasonally adjusted indices for five of the sub-indicators with varying weights: New Orders—30%; Output—25%; Employment—20%; Suppliers' Delivery Time—15%; and Stocks of Major Inputs—10%. A PMI reading above 50 indicates an overall expansion in the manufacturing sector; below 50, an overall contraction.

Currently there are more than twenty countries and regions conducting the PMI survey and compilation, based on an internationally standardized methodology.
